### **Update Current Measures**

#### Saving and Checking Accounts

Suggestions: To add "To open a <u>NEW</u> checking or saving accounts?" Tracking: by an individual that was meeting one-on-one, individuals letting case managers know they did, apply for an IDA. Do you have one or have you opened a new one? Encourage individuals to be banking. Get people who are unbanked – banked.

DTI is directed mostly to housing and budgeting. Banks look at 40% debt to income with the expenses of housing expenses, insurance, property taxes, rent. Government uses 43% debt to income.

#### • Mini IDA Committee

We currently have 13 applications to review. Getting Ahead graduates have all applied for the IDA's. Getting Ahead (GA) Graduation is Thursday, June 15th at 6:00pm for Hudson class and the three (3) Adrian classes with 31 graduate's total. There will be 12-13 individuals to give testimonials. GA did get funded through Lenawee CARES for \$25,000 for the staffing support and classroom books, not the stipends. Burt is going to reach out to community business grants such as Big Lots for stipends and offer to have their employees to take part in the program. Discussed having the services clubs in Hudson attend the graduations to see if they would be a sponsor as well.

- Habitat for Humanity of Lenawee County
  We did get funded for \$13,000 for students "R" Rules. Adrian "R" Rules class is going to happen.

Lynne reported out that this group continues to meet and is growing in size. Mailing list is more than 30 people and is strengthening. This group meets the last Friday of each month at 8:15am at the Family Kitchen Restaurant. There was a suggestion of having Julie present on the Getting Ahead program to bring the landlords aware of this program and what it has to offer.

## **Core Collaborative meeting**

Burt reported out that ProMedica is closing the Physic unit in Tecumseh and is working with the ROSC group on a solution for clients that are in need of assistance. The Engagement Center is going to be a location where people can go to with substance abuse issues and there will be recovery coaches there to meet with individuals. The Engagement Center is going to start out being open 24 hours on weekends with future hours to be determined.
