## **United Way Update:**

United Way has met with some community stakeholders about potentially setting up an Employer Resource Network (ERN) in Lenawee County.

An ERN is a group of businesses that create a small pot of money from which they can offer low-interest loans to their employees and provide supportive services such as budgeting and case management.

ERNs have been having a lot of success in western Michigan. Also, Livingston County has one and Jackson County is working to start one.

Michigan Works! has been very involved in these throughout the state. Also at the state level, they have been looking at the possibility of grants to support the seed money so businesses don't have to put up as much. Misty provided a presentation on ERNs given at the Michigan Works Annual Conference (attached).

What has been the proposed metrics for success? It is important to be able to show Return on Investment for employers – the value of retaining an employee.

In other counties, financial institutions also become involved and began developing products intended for this population. Example: a pre-loaded debit card that acted as a micro-loan to start repairing credit.

Since many of the resources for an ERN are members of LFSC, what can we do collaboratively to support it? Misty will get an update on where things are at and report back.

#### **Core and Community Collaborative Meetings**

Madison and Adrian school districts will be piloting a "Handle with Care" program in which law enforcement will provide a "Handle with Care" notice to the school if a youth or their family is involved in certain types of contact.

#### **Data Collection**

The 2018 questions are very similar to ones being asked for the proposed Continuum of Care dashboard. Is it a possibility / Would it make sense for us combine with that, so our organizations don't have to do it twice?

We will invite Brittany Stover from Housing Help to come speak to us about the Dashboard to see how we can relate to it.

There is also always this question of how to ensure valid and unduplicated data: i.e., if one person gets assistance from both Goodwill and Community Action Agency, they will be counted twice. There is no good way around this without collecting identifying information and comparing data.

## **Goals and Planning for 2018**

Many of the Collective Impact groups have been undergoing an updated planning process. The Collaborative has been around for several years now and we want to make sure that we are all still moving forward. April Demers from CMH has been facilitating many of these processes and has volunteered to come to the February meeting to facilitate a planning session for us.

A proposed goal to consider for the future is to engage local employers. Should this be through the ERN or are there other options? If local employers are not paying a living wage, then our programs can move some people out of poverty, but other people will always be moving into it.

The Lead Remediation Grant wasn't received. This was a collaborative effort with Habitat, CAA, and LISD. They had a conference call with representatives from the state to go through which areas of the application were strong / week. Collaboration was cited as a strength. There will be another RFP coming out around March and these organizations will apply for that one.

Habitat is doing their Pasties fundraiser; apparently the breakfast ones are excellent. Lynne has order forms.
