### III. COVID-19

#### a. Current Needs

#### b. Future Needs

State of Michigan allocated \$60 mil across the state, \$50 mil going to direct assistance, \$250,000 was locally allocated to Lenawee county for eviction diversion; there is a workgroup that is meeting weekly, includes h2l, caa, dhhs, lsscm, sdrs; funds must be spent by December, but there is hope that the program will become sustainable after this; there are financial eligibility for participation and requires landlord involvement; if someone is 50% ami or lower, program could pay up to 90% of unpaid rent from March through June; will find out from mshda next week if these funds can be used prior to a summons

Housing help received funds from efsp for rent/mortgage assistance

Moratorium on evictions and utility shut offs are ending soon, expect to see needs

Seeing issues with land contracts; these often don't fall into either rent or mortgage rules; clint will ask Patrick if he could come speak to us about this issue

Caa is unable to do their migrant health clinic this year; trying to figure out how this might operate virtually or in some other way
