B. 6 Principles of Trauma-Informed Care: Trustworthiness and Transparency

We introduced the second principle of Trauma-Informed Care: Trustworthiness and Transparency. This principle is about using transparency when we're making decisions, communicating with one another, and when we're working with consumers. Some questions we can be asking when we do this work are:

- What strategies are we using to reduce power differentials between ourselves and the residents that we work with? Do our consumers know why we're making the decisions that we're making?
- How are we keeping people informed of rules, procedures, activities, schedules, etc., being mindful of all the different ways people process information?

EVERYONE will bring an example of what Trustworthiness and Transparency looks like in their work to share at the next meeting.

A. Blight Remediation

1. What has happened since our last meeting?

- Leslie Love continues to prepare for the Neighborhood Enhancement Program with the hope that the City of Adrian will apply for the grant.
- There is a grant opportunity through MSHDA called MI HOPE (Michigan Housing Opportunities Promoting Energy-Efficiency) for neighborhood revitalization. Community Action Agency will be applying for this grant – the application is due on Monday. The grant will be for \$1 million split across the counties CAA works in. CAA has a team that does lead remediation in homes, and would use

this construction crew to do other home repairs in the community. Hopefully this existing capacity will strengthen CAA's application!

B. Increase Participation in Financial Education Programs

1. What has happened since our last meeting?

- There is a meeting this fall with all the counselors, principals, Lenawee Now, and other interested agencies to discuss career preparation in schools. The goal is to emphasize that community resources already exist to provide the curriculum for schools.
- Homebuyer Education courses in-person started in Jackson. These courses will start in Lenawee County in September.
- We are still waiting for dates to get the Eastside Education program going, with the goal of starting in September.
- Val Herr from Goodwill is transitioning to a new role, putting the Goodwill Education Series on hold.

2. What did we learn?

- We need to clarify which entities are able to provide education for students.
- If the church isn't available for the Eastside Education program, we can also use the Comstock Building. CAA is also an option to host.
- The Ebeid Neighborhood Project is summarizing all the results from the planning sessions that happened this summer, and are working to set an advisory committee that can start meeting in September. The group is also working to secure a location for the center.

- a. There were 200 residents displaced. As of this meeting, 75 of them are being moved to different hotels (Adrian Inn, Super 8, Tecumseh Inn...). Most residents do not have long-term plans for housing right now. Many residents were living on a fixed income and are now struggling to find housing outside of their low-income apartment building. We'll want to continue thinking about how we can support residents in a trauma-informed way.
