#### d. LCMHA

- i. All services are still being offered.
- e. Michigan Works! South East
  - i. MWSE is now open by appointment; only one customer is allowed at a time.

#### f. DHHS

- i. DHHS staff will begin to transition back to the offices once the state is at Level 5.
- g. Community Action Agency
  - i. Virtual classes are available:
    - 1. Mystery of Credit Scores -9/9 from 10 11:30 am
    - 2. Crisis Budgeting 9/10 from 10 Noon
    - 3. Foreclosure -9/10 from 2-3 pm
    - 4. Homebuyer Ed -9/19 from 9 am -1 pm
  - ii. CAA is hiring for several positions. More information is available on the website
  - iii. The Governor has issued an Executive Order that all migrant farmworkers be tested by 8/24. There are approximately 250 migrant workers in Lenawee County. According to the order, the grower is responsible for ensuring that this happens that people who test

positive are able to isolate themselves. There is a stipend available to the workers who must isolate.

#### h. Goodwill

- Goodwill is winding down their summer programs and trying to plan for school reopenings.
- i. Habitat for Humanity
  - Rock the Block will be focused on East Maumee Street on 9/11-12. Anyone interested in volunteering can sign up on the Habitat website. Social distancing and masks will be required.
  - ii. There will be two new builds this year.
- i. UWMLC
  - i. Day of Action will be coordinated with Habitat's Rock the Block.
- k. Veteran's Affairs
  - i. Meijer vouchers are available on a first come first serve until 9/30. Additional funds are available for peacetime and wartime veterans.
- l. Project Connect / PiT Count
  - i. It is unclear what this will look like for 2021. Elizabeth will reach out to HUD for clarification.
- m. Veteran Employment Services
  - i. Assistance is still available although employees are working remotely. It is recommended that interested persons hold a remote appointment with Michigan Works first so that they can be made aware of all available assistance options.
- n. disAbility Connections
