## 5. Grants

- a. CERA 2
  - i. We received an additional \$1,000,000 for client assistance. We project this will sustain us until July. We currently have the lowest load of applications that we've had throughout the pandemic, so Housing Help will be doing some additional promotions to encourage folks to apply. To qualify, applicants must have late rent from March 30<sup>th</sup> of 2022 or before. Please help encourage folks to apply!
- b. MI HAP
  - i. Housing Help is getting more inquiries from folks about mortgage assistance. Please encourage folks to go to Community Action Agency. They have a program that is very similar to CERA, only for mortgages. It allows folks to get caught up on rent for mobile homes, property taxes, homeowners insurance, utilities, and land contracts. Up to \$25,000 is available for participants. This program is separate from Housing Help and encourage folks to go directly to CAA!
- c. Emergency Food and Shelter Program
  - i. United Way's annual allotment should be released soon!
