**LHN Leadership Updates:**

Collective Impact Core

- Walk for Warmth event is scheduled for March 6, 2020 from 11:30 am until 1 pm. Consumers Energy is no longer providing their 2:1 match contribution to the event. This will have significant implications on the funding available to support residents in need of utilities assistance.

Building a Trauma Informed Community

- CIC, with leadership from Community Mental Health, submitted an application to the National Child Traumatic Stress Initiative Grant. This opportunity can provide resources and funding to accelerate the implementation of trauma initiatives in Lenawee.
- CIC has established a sub-committee to review an electronic trauma-screening tool that will assist organizations to better assess their readiness and starting point of becoming trauma informed.

2020 Census

#### Intergenerational Programming

#### Age-Friendly Communities

- ProMedica is participating in a Michigan Hospital Association demonstration project to build an Age-Friendly Health System. During this process, we have re-visited how communities can develop and implement Age-Friendly communities. Upon exploring the components of an Age-Friendly community, it was recognized that these components include many factors that our community currently discusses.
- Frank has proposed that our LHN consider a collective and collaborative strategy to work towards becoming an Age-Friendly recognized community through the work of the LHN.

## **Opioid Addiction and Abuse:**

### HRSA RCORP Planning – Lenawee Opioid Response Project

- The planning grant has developed a 2019 Lenawee Opioid Assessment, a Gaps/Needs Analysis, and a comprehensive Strategic Plan. The project is now conducting Sustainability planning sessions with Strategic Innovations Group LLC. at the monthly LSAPC meetings from February through April. ### HRSA RCORP Implementation Grant NOFO

- The NOFO for the HRSA RCORP Implementation grant was released last week. ProMedica Bixby Hospital is willing to be the lead applicant and fiduciary of the project, if awarded. HRSA is awarding 89 communities with three years of funding totaling a maximum of \$1,000,000 to implement their strategic plans to combat opioids.
- As a planning grant recipient, our community is well positioned to develop an application. Planning meetings to construct the application will be scheduled as soon as possible.

## **Overweight and Obesity Incidence:**

### MDHHS 4x4 SPAN – Physical Activity Grant

- MDHHS is hosting a Transportation Bonanza today. Martha Hall from the Health Department is attending on behalf of the project and the LHN. This event will provide our community with resources related to the development of non-motorized and motorized paths.
- The grant project started 01/01/2020 and is presently working with partners to identify a platform to bring all parties to one table to coordinate non-motorized activities in the county.

### Open Floor Updates

- Region 2 AAA in Jackson is providing a workplace PATH program that encourages strategy implementation to support employee health and a healthy work place.
- Region 2 AAA has trained a leader for Diabetes PATH fluent in Spanish. The program will launch this spring and is a collaboration with Family Medical Center, Lenawee County Health Department, and Region 2 AAA.
