Collective Impact Core

Quality of Life for Older Adults:

<u>Department on Aging</u> is focusing on programming that provides meals delivered to the home and curbside pickup. The demand for home delivered meals is growing and will continue to grow. Currently, six Senior Centers are offering curbside meals, which functions by the resident pulling up to the location to "see a familiar face and to receive a hot noon time meal".

- Also offering puzzles and other activities to provide cognitive stimulation for older adults.
- Conducting well checks with older adults to inquire if they are in need of resource and to have conversation with individuals so that they feel less isolated.
- The Caregiver Conference has been cancelled but resources are reallocated to provide support to caregivers that are confined to the home. If someone is in need of this meeting, please reach out to the Department on Aging.

<u>Region 2 Area Agency on Aging</u>'s offices are operational. Their agency has been identified by the state to receive volunteers and meal requests.

- Region 2 AAA launched the Friendly Reassurance program. This program utilizes staff and volunteers to conduct outreach to older adults on a weekly basis. The purpose is to reduce social isolation older adults are experiencing and to evaluate the person's emotional well-being status and resources needed.
- If people are in need of resources they can call 517-592-1974

<u>Thome PACE</u> is continuing to take referrals. Home care staff are going into the homes of priority locations to check in on the well-being of residents. Further, well check phone calls are being conducted to evaluate well-being and resources needed.

- Was awarded a grant to receive 28 iPads to conduct Telehealth and to provide mental health support. More details to come.

<u>YMCA of Lenawee</u> is conducting well calls with older adult members and to connect to needed resources.

Opioid Addiction and Abuse:

HRSA RCORP Planning – Lenawee Opioid Response Project

- Sustainability planning sessions are scheduled to resume in May at the LSAPC meeting. It is unknown the format of the meeting at this point but current circumstances lean toward a Zoom meeting facilitated by Strategic Innovations Solutions LLC.
- HRSA is communicating that a project extension is likely for all HRSA grantees due to the COVID-19 outbreak. More updates are coming in April to confirm final details.

HRSA RCORP Implementation Grant NOFO

- LHN Leadership and LSAPC Executive Committee have started meeting and developing the grant application for the HRSA RCORP Implementation Grant. If your agency is interested in supporting the completion of the grant application, please email Frank Nagle -> Frank.Nagle@ProMedica.org.

April Drug Take Back Day

- The Drug Take Back Day scheduled for April 25, 2020 is cancelled due to the COVID-19 outbreak. Please share with your agency, consumers, and coalitions.

Overweight and Obesity Incidence:

MDHHS 4x4 SPAN – Physical Activity Grant

- This grant project has a technical assistance call with MDHHS on April 14, 2020 to understand how projects are proceeding across the state. Current information indicates projects will be paused on

implementing projects due to COVID-19 but that communities can utilize funds to support education of safe and appropriate physical activity.

Physical Activity

- Connecting Lenawee Task Force is scheduled to resume meetings via Zoom format on April 16, 2020.
- Opportunity exists for LHN to connect with the community and to organize safe physical activity in accordance with COVID-19 guidelines/restrictions.

Food Access

- Habitat for Humanity has developed a housing food pantry. This resource is available for the residents in the City of Adrian and are eligible to have food delivered via a mobile device application.

 - o ProMedica Bixby Hospital is moving forward with a Michigan Health Endowment Fund grant application and is asking for LHN member support to collaborate. The focus is expanding nutrition and physical activity education in the community and at ProMedica Farms.
 - Components of the proposed project include: Food Access/Availability, Gardening
 (Intergenerational), Evidence-Based Education/Workshops, and Social Determinants of Health.
