Leadership Updates:

2020 Lenawee Community Health Assessment:

- ProMedica Bixby Hospital has scheduled the 2020 Lenawee Community Health Assessment with Hospital Council of Northwest Ohio. Plans include the conduction of Adult and Child surveying and to fold MiPHY data into the final assessment.
- Hospital Council of Northwest Ohio will facilitate the process with LHN Leadership and members starting in quarter three of 2020. Final presentation to the community is anticipated in April 2021.

Quality of Life for Older Adults:

Senior Lifestyle Expo:

- Department on Aging is evaluating the format and logistics of the Senior Lifestyle Expo in 2020. The event traditionally has large crowds congregating to access vendor resources. As a network, how to we provide the value of events to residents while following physical distancing and COVID guidelines?

Social Isolation – Friendly Reassurance Program:

- The Friendly Reassurance program continues for Region 2 AAA. Older adults are contacted by volunteers to identify needs and linkages to resources. The program connects with individuals as a means to reduce social isolation that may be experienced as well. Opioid Addiction and Abuse:

HRSA RCORP Planning – Lenawee Opioid Response Project

- HRSA has extended all grantees up to November 30, 2020. The Lenawee Opioid Response Project is submitting a request to accept the full extension.
- Strategic Innovations Group LLC. facilitated the final sustainability planning session on June 3, 2020. A draft of the sustainability plan will be submitted to project management by June 19, 2020.
- LSAPC project based workgroups will begin to assemble in July.

HRSA RCORP Implementation Grant NOFO

- Application is submitted to HRSA. Notice of Award should be released by August 2020. If awarded, the project will start September 1, 2020.

Overweight and Obesity Incidence:

MDHHS 4x4 SPAN – Physical Activity Grant

- Through the City of Adrian, this project is evaluating the feasibility to implement at grade safety crossing enhancements at M-52 and Curtis and Maumee intersection of the Kiwanis Trail near the Family Dollar and Comstock Park.
- Michigan communities have developed signage providing guidance on physical distancing and COVID precautions while utilizing local parks and trails. The project will review materials already developed and opportunity to tailor signage to Lenawee.

Food Access

- Region 2 AAA, Department on Aging, and ProMedica Veggie Mobile have collaborated on the USDA Fresh Food Distribution. Each week, 50 produce boxes are delivered to ProMedica Farms. Older adults accessing the Veggie Mobile and experiencing food access challenges can redeem a box following the completion of a program form. Thus far 150 boxes weighing nearly 2,400 pounds has been distributed in Lenawee.

Events/Health Screenings

- United Way of Monroe and Lenawee reports that the April Health Check Event is cancelled. An event is tentatively scheduled for the fall.

Evidence-Based Programming

- MSU-Extension has established online nutrition education series that will continue until the fall. Link to register -> <https://events.anr.msu.edu/npavirtual/>
- Region 2 AAA held their first virtual Diabetes PATH workshop. Participation in the virtual platforms has been great.

- ProMedica Diabetes Education offers free support group to the public. This group takes place every 3rd Tuesday of the month. If interested, please email Juliana Moore -> Juliana.Moore@ProMedica.org

Emerging Issues:

- United Way of Monroe/Lenawee has WIFI available in their parking lot for anyone in need of access. Project Ramp task force is meeting again and has great support from volunteers.
- disAbility Connections is conducting an unmet needs survey. The survey is identifying gaps people with disabilities are experiencing as COVID-19 has broken out. The link will be shared with members.
- Region 2 AAA is holding the Safe Haven benefit event on Wednesday. This event is virtual and taking place on June 17, 2020 at 4:00 pm.
- Family Medical Center has resumed dental services. If you identify anyone in need of dental care, please refer them to Family Medical Center.
