COVID-19:

- As of 07/01, Lenawee County has the following positive cases:
 - o 92 males and 90 females
 - o 3 hospitalized
 - o 27 monitoring at home
 - o 146 discontinued from isolation and improving
 - o 6 deaths

Building a Trauma Informed Community:

- As staff return to your agency, please know that Lenawee Community Mental Health Authority has resources available to support people coming back to work.

2020 Census:

- Census deadline has been extended to October 31, 2020. <https://2020census.gov/>
- 70% return response rate for Lenawee as compared to 68.1% for Michigan and 61.8% for the nation.

Leadership Updates:

2020 Lenawee Community Health Assessment:

- A partially executed contract is submitted from Hospital Council of Northwest Ohio to ProMedica Bixby Hospital. The hospital senior leadership will review and sign. Upon signature, Frank will submit to HCNO.
- The survey tools will be developed over the remaining summer of 2020 and final document will be available for presentation to the community in the spring of 2021.

2021-2022 Lenawee Community Health Improvement Plan (CHIP):

- Recommended by Frank Nagle to modify the structure of the LHN from one with three objectives of Improving quality of life of older adults, reducing opioid addiction and use, and reducing the overweight/obesity incidence to one with overarching components reaching specific populations of focus. Proposed structure includes:
 - o Leadership Component
 - o Chronic Conditions Component
 - o Behavioral/Mental Health Component
 - o Social Determinants of Health Component
- Upon receipt of the 2020 Lenawee Community Health Assessment, the LHN will identify the top 2-3 priorities for each component and develop strategy under each. Please see meeting slides for more details.

Quality of Life for Older Adults:

Social Isolation – Friendly Reassurance Program:

- The Friendly Reassurance program has grown since last month. The program will be sustained for the foreseeable future.
