 - o 208 males and 210 females
 - o 1 hospitalized
 - o 151 monitoring at home
 - o 254 discontinued from isolation and improving
 - o 12 deaths

Leadership Updates:

2020 Lenawee Community Health Assessment:

- The contract with Hospital Council of Northwest Ohio (HNCO) has been fully executed to being the development of the 2020 Lenawee Community Health Assessment.
- LHN Leadership has scheduled the first meeting with HNCO on 09/02/2020 to develop the survey tools for adults and children. 115 questions is available for the adult survey and 75 for the child survey.
 - Members/participants are asked to review the IRB approved questions compared to questions asked in the 2017 Lenawee survey.

 - Questions included in the survey must provide our community with data that informs decision-making and strategic planning to address the community's needs. Questions not providing this information will not be included in the survey.

Diversity, Equity & Inclusion

- Dr. Jennifer L. Eberhardt, PhD. Is a social psychologist with Stanford University working with the psychological association between race and crime. Please view the following TED Talk:
 - o <u>How racial bias works and how to disrupt it</u> –> Key messages are as follows:
 - CDC reports that 36% of the country's population belongs to a racial or ethnic minority group.
 - Technology can be a supportive tool when used appropriately. Next Door App developed to allow neighbors to communicate with one another on one platform. The app soon realized they had an issue with racial profiling. To address this, they worked with Dr. Eberhardt and added friction to slow people down. The friction is developed in the form of a check list that asks the individual the following questions:

- Pause and think what was the person doing that caught your attention?
- Describe the person what are their physical features. Exclude race/ethnic descriptions
- Review the definition of racial profiling. Understand it is not tolerated.
- o We can interrupt bias by pausing and reflecting.

Opioid Addiction and Abuse:

HRSA RCORP Planning – Lenawee Opioid Response Project

- 8 project based work groups continue to meet. The groups are focusing efforts on transitioning from planning into implementation of the LSAPC Opioid related strategic plan.

HRSA RCORP Implementation Grant NOFO

- On August 06, 2020, Frank Nagle received a Notice of Award email from the Health Resources and Services Administration (HRSA) indicating that on behalf of the Lenawee Substance Abuse Prevention Coalition (LSAPC) and Lenawee Health Network (LHN), ProMedica Bixby Hospital has been awarded the HRSA Rural Communities Opioid Response Implementation grant.
 - o Project starts 09/01/2020 and ends 08/31/2023
 - o Awarded \$1,000,000 spread across three years.
 - Purpose to reduce the morbidity and mortality associated with Substance Use Disorder (SUD) and Opioid Use Disorder (OUD) through the implementation of evidence-based policies/systems/and environmental enhancements.
