The meeting was called to order at 3:00 pm by Nate Smith, Committee Chair.

7. <u>CMHA DUES</u>

CMHA dues went up about 4% from last year. FY 24/25 dues total \$14,631. **MOTION BY A PALMER** to approve payment of the CMHA dues in the full amount of \$14,631. **SUPPORT BY N WILSON. MOTION CARRIED**

8. <u>DATA REPORT</u>

Mental Health Inquiries: Kathryn reported that in November we had 70 mental health inquiries. 19 were initially referred out. 48 intakes were scheduled, 3 declined/no need. 40 initial assessments were completed with 10 found to be ineligible, 1 declined, 29 eligible and receiving services. 69% Medicaid, 31% Healthy Michigan.

Substance Use Disorder Inquiries: In November, Substance Use Disorder Inquiries totaled 44. 5 were referred out, 4 with benefits, 1 was not a Lenawee county resident and was referred to local resourced. 39 were authorized. 25 Healthy Michigan, 12 Medicaid, 2 Block Grant.

Inpatient Hospitalizations: There were a total of 24 people admitted to hospital in November. 71% Medicaid, 25% Healthy Michigan, 4% (1) GF. 33% had co-occurring mental health and substance use disorders. 63% were previously unknown to us. 7 reported the Family Medical Center as their primary health care provider, 10 with no primary healthcare provider. We were able to divert 3. 14 went in on petition. 2 no show for a follow up appointment despite attempts to contact.

9. <u>FINANCE REPORT</u>

We are 8% through the fiscal year, at 7% spent, about 1% under budget. We are slightly overspent in Healthy Michigan at this time, but we have Medicaid carry forward to help cover this. At this time, we are having to take around \$694 to the fund balance. General Fund investment and Hendershot both saw a decrease.

Kathryn reported on the Recipient Rights Advisory Committee. The committee reviewed the ORR annual report and received training on an updated interpretation of the Protected Rights Code. The committee recommending accepting the Annual report, accomplished and desired outcomes, and recommended continuing to support and fund the Rights Office at its current level
